



# NEW VEHICLE WARRANTY CERTIFICATE

- **Unlimited Mileage!**
- **Unlimited Transfer of Ownership!**
- **Renewable Annually Forever!**

This warranty applies to a New Vehicle, provided that the vehicle is not older than six months and upon inspection and approval by a Dura Tech center. The warranty covers your vehicle Forever, provided Dura Tech is reapplied each year.

## 1. Terms:

Provided that Dura Tech has been reapplied annually to the vehicle by a Dura Tech center within 13 months of the last application, Dura Tech warrants that it will repair or replace at its cost all original body panels from the below the window sills which have rusted through from the inside out.

The panels treated with Dura Tech and covered by this warranty are the underside of the vehicle, the front and rear fender panels, the doors, the rocker panels, the hood, the trunk lid and back panel.

All invoices will be required as proof, in case of a claim. Claims must be made in writing to a Dura Tech center within 12 months of the last application of the Dura Tech on your vehicle.

The customer must obtain a written authorization from the Dura Tech center before proceeding with any repairs.

## 2. Damaged Vehicle:

If your vehicle is involved in an accident you must contact your Dura Tech center within 15 days for reapplication to the damaged area of your vehicle. This reapplication will be done at no expense to the owner.

In the event that the Dura Tech center, in its discretion considers the damage extensive or the repairs inferior, it may cancel this warranty in part or in full. Failure to reapply Dura Tech in these circumstances voids this warranty.

## 3. Areas Not Covered:

This warranty does not apply to rust penetrating the vehicle panels from the outside, meaning the side opposite the one where the treatment was applied and caused by lack of maintenance, paint fraying, scratches, does not include moldings or areas damaged following a collision or vandalism. Also mechanical or mechanically related components, areas filled with insulation, the gas tank, the muffler and other exhaust components, the roof, door posts and the paint not being accessible to the treatment, are not included in the warranty.

Corrosion related to design flaws is the responsibility of the manufacturer and is not covered in this warranty.

## 4. Limitations:

This warranty is offered in lieu of any and all express or implied warranties and Dura Tech shall have no further liability whatsoever for damages other than those set out herein (including no liability for lost time, inconvenience, consequential or incidental damages or loss of vehicle). Dura Tech limits its costs of repairs or replacement to the current wholesale cash value of the vehicle if a warranty claim is made.

## 5. Transferring the Warranty:

Should you sell your vehicle, the current warranty is transferable free of charge to the new owner.

The new owner must present this certificate for the warranty to be transferred. The warranty will then remain in force and the same conditions and exclusions will apply to the new owner.
